


## Investment Philosophy


## Strategy Objective

The Titan Moderate Growth strategy is designed to generate growth with some income. It seeks to deliver higher returns with less downside volatility than the 60/40 balanced index. The strategy includes multiple models and can invest in stocks, commodities, REITs, MLPs, bonds, currencies or cash. There are no fixed allocations to any of the asset classes mentioned above. The strategy has the ability to allocate up to 80% in stocks as well as 100% in cash.
