

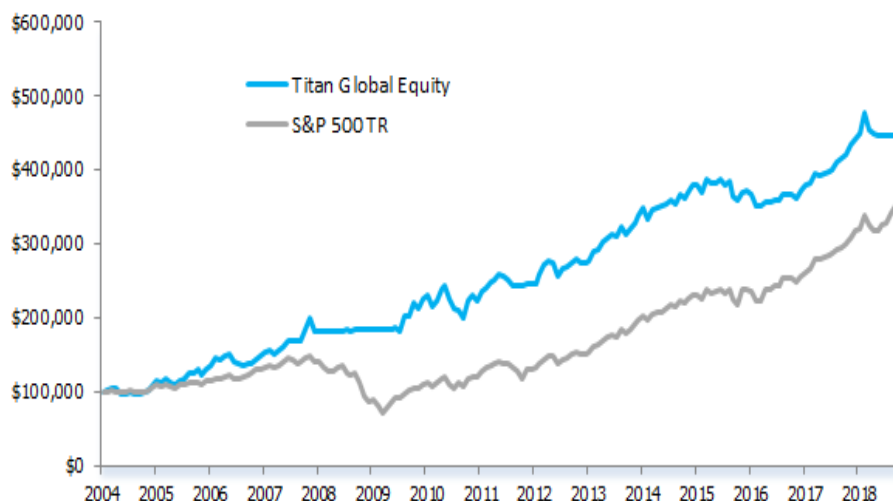
### Investment Philosophy

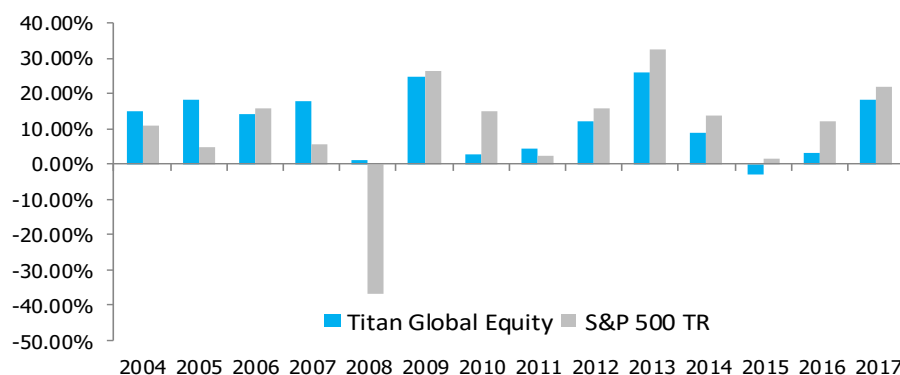
### Strategy Objective

The Titan Global Equity strategy seeks to generate above market risk-adjusted returns with less downside volatility than the broad equity market. The strategy includes multiple models that primarily invest in global stocks using ETFs. There are no fixed allocations to any asset classes. The strategy has the ability to allocate up to 100% in stocks as well as 100% in cash. This strategy is ideal for smaller accounts that want to utilize a tactical approach.
